Basic Beliefs of the Wesleyan Church

(taken from the Articles of Religion of The Wesleyan Church)

- -We believe in the Holy Trinity, One God in three—the Father, the Son, and the Holy Spirit. We believe the Father is the Source of all that exists. We believe that Jesus Christ is the only begotten Son of God, He died on the cross, was buried, to be a sacrifice for all sin and to reconcile us to God. We believe that Christ rose bodily from the dead and ascended into heaven and will return to judge all humanity at the last day. We believe in the Holy Spirit who is the administrator of grace to all, He is ever present, assuring, preserving, guiding and enabling the believer.
- -We believe that the Old and New Testaments are the Holy Scriptures. They are the inspired and infallible Word of God, inerrant in their original manuscripts and superior to all human authority. We believe they contain all things necessary to salvation; so that whatever is not read therein, nor proven by them should not be required by any man or woman as a requisite to salvation.
- -We believe that God's purpose for Humanity is that we love God with all our heart, and others as He loves us. Therefore, all persons should order their individual, social, and political acts to give to God entire and absolute obedience and to assure to all the enjoyment of every natural right, as well as to promote the fulfillment of each in the possession and exercise of such rights.
- -We believe every person is created in the image of God and that human sexuality reflects that image in terms of intimate love, communication, fellowship, subordination of self to the larger whole and fulfillment. God's Word uses marriage as the supreme metaphor for His relationship with His people and for revealing the truth of this relationship. Sin can be willful or involuntary, but Christ offering of himself, once and for all is the only acceptable atonement by which any may have salvation.
- -We believe that men and women must voluntarily respond to Christ sacrifice for their sins through repentance and faith. We believe when a person repents, they are in that moment justified, regenerated and adopted into the family of God and assured of personal salvation through the witness of the Holy Spirit. Although, even after we have experience regeneration, it is possible to fall into sin, but my the grace of God one who has fallen into sin may by true repentance and faith find forgiveness and restoration.

- -We believe that although good works cannot save us, that they are the fruit of faith that follow regeneration, are pleasing to God, and by them a living faith may be known.
- -We believe that sanctification is the world of the Holy Spirit by which the Child of God is separated from sin and is able to love God with their full hear and live their lives blamelessly. We believe the Holy Spirit enables individuals to serve the Church through gifts that make the whole Church better.
- -We belied that Christian Church is the entire body of believers in Jesus Christ. The Wesleyan Church is just a part of this.
- -We believe that water baptism and the Lord's Supper are the sacrament of the church commanded by Christ and ordained as a means of Grace when received through faith.
- -We believe that the certainty of the personal and imminent return of Christ inspires holy living and passion for the evangelization of the world. At His return, He will fulfill all prophecies made concerning His final and complete triumph over evil.
- -We believe in the bodily resurrection from the dead of all people; of the just to eternal life and the unjust unto damnation. We believe the Scripture reveal God as the Judge of all and the acts of His judgment are based on His omniscience and eternal justice. We believe the Scriptures teach there is a conscious personal existence after death and the destiny of each person is determined by God's grace and that person's response to His grace.
